Pre-Mediation \$40 per hour per person – (Minus \$20) for first 30 minutes

Mediation sessions: \$125 per party per session

\$45/per party per session for 3 or more parties.

Advocacy - \$90-110 per hour split equally between two parties

Minimum of one (1) hour \$75.00

(\$25.00 for each additional 30 minutes).

Payment is required before release of information.
